Abstract

Socio-political processes, trends taking place in the world promote the demand for the further development of liberal democratic principles of national and international relations. Ensuring constructive dialogue between the state and society, the organization and support of national policy, based on the rapid and modern international demands of domestic and foreign policy, are setting new tasks for the political elite. The secret of such tasks requires the conduct of socio-political activities aimed at ensuring the stability of the internal environment, the formation of socio-political consciousness and thinking of members of society, their protection from the harmful effects of the external environment on various manifestations.
