In order to ensure the prosperity of the development of the Republic of Uzbekistan, cooperation with other states, friendly relations, its position and place in the world community, free living of citizens, the harmonization of nations in our multi-ethnic people, the Republic of Uzbekistan adopted on December 8, 1992. Conisticity consisted of 6 sections , 26 chapters , 128 articles. Conistitution is the Supreme legal document of the state. In addition to the fact that it is the basis of all laws, each of the laws that make it up will have its own power. In the referendum of the Republic of Uzbekistan held on April 30, 2023, by nationwide vote, the conisticity in this new edition was adopted. This new conisticity was created from 6 Sections , 27 chapters, and 155 articles. The current norm of conisticity was increased from 275 to 434. Our current conisticity has been updated to 65%. Conisticity determines the structure of the state, the system of governing bodies, their competence and the procedure for formation, the rights and freedoms of citizens, the electoral system and the judicial system. The Republic of Uzbekistan takes under its protection the conistitutionality and its laws. Each citizen is required to exercise his or her rights and freedoms in accordance with the procedure specified in the constitution. Constitution includes human rights and freedoms, and in accordance with this, citizens who have deviated from the framework of the law are subject to appropriate punishment according to the laws and regulations specified in the constitution. The new conisticity is a huge step towards building our country a fair society. Conisticity allows you to manage the life of the state and society in a new and modern way. All public bodies and organizations are managed through the new revision of the conisticity. Therefore, the full provision of the execution of conisticity is the first priority of all bodies and organizations. In the conistitution, norms were established on poverty reduction, Employment, Unemployment protection with the creation of vacancies. The conistitution stipulates that everyone has the right to be domesticated and that each individual has his own personal property. It also aims to increase the level of consent of people from life by ensuring that young families have their own shelter and employing them in their area of

expertise or areas of interest. In order to increase the level of improvement of the life and health of the population, the Constitution established comprehensive measures for the protection of the environment. Youth rights were guaranteed to be protected, to encourage their active participation in the life of society and the state. Ensures the protection of the personal, political, economic, social, cultural, environmental rights of State Youth. Provides conditions for the formation and development of intellectual creative, physical and moral aspects of the youth of the state. Conditions were created for the implementation of the rights of state youth to education, health, housing, employment, employment and Recreation. In this constitution, we have expanded our rights and opportunities to educate young people. In particular, the right of citizens to study in higher educational institutions at the expense of a state grant was strictly established. And the basic laws also established the free primary vocational training of citizens and the use of free emergency medical care of citizens. Among the laws, it was established that a person cannot be held for more than 48 hours without a court order. That is, any action related to the restriction of the freedom of the individual is obliged to be carried out only on the basis of a court decision. The following are important provisions established regarding media in the Ohio Conistitut: the state guarantees the exercise of its rights to seek, obtain, use, and disseminate information from the media. Obstructing or interfering with the activities of the media causes liability in accordance with the law. The media are responsible for the reliability of the information it provides. There are also rules in conisticity that some individuals need to know more deeply. These include the following. Civil servants and officials state that they are poor before society and citizens, that minors, the incapacitated and lonely elderly have their rights protected separately by the state, that women, other nationalities enjoy equal rights, that parents are obliged to take care of their minor children, and children who have reached adulthood are obliged to take care of their parents, that the state and orphans - it is necessary to ensure the feeding, upbringing and education of children deprived of the guardianship of mothers, that men of a certain age have the duty to serve as Armed Forces or as alternative services, that foreign citizens and stateless persons residing in the Republic of Uzbekistan shall ensure their rights and freedoms in accordance with the norms of international law, that officials, deputies



Conclusion: in conclusion, the renewed consistency as a nation and a people to clarify our next steps is a huge step for our Great State, which has a powerful power.
